**ELECTOR REGISTRATION**

There is no need to pre-register to vote as the registration of all electors for this election will take place at the time of voting. You will be required to make a declaration that you meet the following requirements:

- 18 years of age or older on general voting day
- Canadian citizen
- resident of BC for at least 6 months immediately preceding the day of registration
- resident of OR registered owner of real property in electoral area: “A” (Bamfield), “B” (Beaufort), “D” (Sproat Lake), “E” (Beaver Creek), “F” (Cherry Creek) or treaty first nation: Huu-ay-aht First Nation or Uchucklesaht Tribe Government for at least 30 days immediately preceding the day of registration, and
- not disqualified by the *Local Government Act* or any other enactment from voting in an election or otherwise disqualified by law.

**Resident electors** must produce **2 pieces of identification** (at least one with a signature). Picture identification is not necessary. The identification must prove both residency and identity.

**Non-resident property electors** must produce **2 pieces of identification** (at least one with a signature) to prove identity, **proof** that they are entitled to register in relation to the property, and, if there is more than one owner of the property, **written consent** from the majority of the property owners to one owner voting. **Non-Resident Property Elector Consent forms** can be downloaded off the Regional District website at [www.acrd.bc.ca](http://www.acrd.bc.ca).

**MAIL BALLOT VOTING**

Qualified electors may vote by mail if they:

- Have a physical disability, illness or injury that affects their ability to vote at another voting opportunity;  
or
- Expect to be absent from the Regional District of Alberni-Clayoquot on general voting day and at the times of all advance voting opportunities, or
- Reside in Electoral Areas: “A” (Bamfield), “D” (Sproat Lake) or treaty first nations: Huu-ay-aht First Nations or Uchucklesaht Tribe Government where:

- i. Their only access to their residence is by boat or aircraft, or
- ii. Their travel time by road from their residence to the nearest voting place at which the person is entitled to vote is greater than thirty minutes.

**REQUESTING A MAIL BALLOT PACKAGE:**

Qualified Electors who are eligible to vote by mail and wish to vote, must apply in writing to the Chief Election Officer before **12 noon on Friday, November 14, 2014**. **Mail Ballot Package Request Forms** are available on the Regional District website [www.acrd.bc.ca](http://www.acrd.bc.ca) or by contacting the Chief Election Officer at (250) 720-2700.
